### Qualifying Customers

Residential electric customers who purchase their electricity from a UAMPS participating energy partner are eligible to participate in the Heat Pump Incentive program.

### Qualifying Equipment

- **Requirements for all heat pumps:** Work must be completed by a qualified HVAC contractor. Minimum of 9.0 HSPF (“heating seasonal performance factor”), 15 SEER (“seasonal energy efficiency ratio”) for tier 1 heat pumps, and minimum of 9.5 HSPF, 16 SEER for tier 2 heat pumps. Heat pump must be a new air-split or packaged unitary heat pump with an AHRI standard rating cooling capacity of 65,000 BTU/hr. (5.4 tons) or less. Heat pump must be listed on the AHRI certified directory. New heat pump must be the current primary heat source and must service at least 80% of the homes conditioned living space. Homes 3,500 square feet or less may qualify for one unit, while homes greater than 3,500 square feet may qualify for two units. Must be an existing home, new construction does not qualify.

### Incentive Schedule

- Customer Heat Pump Tier 1 Incentive (9.0 HSPF, 15 SEER) - \$200, Trade Ally Incentive - \$50
- Customer Heat Pump Tier 2 Incentive (9.5 HSPF, 16 SEER) - \$400, Trade Ally Incentive - \$200

### Application Details

UAMPS is administering this incentive program for its participating energy partners. If UAMPS inspects the equipment, the incentive application will not be processed until the inspection has been satisfactorily completed. UAMPS reserves the right to inspect and/or install temporary air conditioning monitoring equipment on any installation of qualifying equipment at any time up to 24 months after installation for quality control of the application or program performance evaluations. Incentive qualifications and amounts are subject to change and termination at any time.
